PER CURIAM:

Kevin L. Butler, appointed counsel for Backari Mackey in this direct criminal appeal, has moved to withdraw from further representation of the

appellant and filed a brief pursuant to *Anders v. California*, 386 U.S. 738 (1967).

Our independent review of the entire record reveals that counsel's assessment of the relative merit of the appeal is correct. Because independent examination of the entire record reveals no arguable issues of merit, counsel's motion to withdraw is **GRANTED**, and the district court's order modifying the terms of Mackey's supervised release is **AFFIRMED**.<sup>1</sup>

<sup>1</sup> We note that Mackey has apparently satisfied the district court's special supervised-release condition that he reside in a halfway house for six months, and that he is no longer subject to that condition. To the extent this renders his appeal moot, the proceedings are hereby dismissed. See *United States v. Farmer*, 923 F.2d 1557, 1568 (11th Cir. 1991) (holding that appeal from sentence was rendered moot by the defendant's release from custody).
